

CHILDREN'S PLAYROOM

NOTICE:

RULES AND REGULATIONS:

1. Operational Hours are from 9:00 a.m. - 9:00 p.m. daily except when closed by the Management (*whether for maintenance works or otherwise*).
2. Children **below 12 years** must be accompanied and supervised at all times by an adult.
3. All persons entering the Room, must be suitably, properly and decently attired (*swimming or other wet attire is not permitted*), and must remove all shoes, slippers and other footwear before entering the Room.
4. Pets, smoking, food and littering, are all not permitted in the Room.
5. No tampering, damage or loss shall be caused to the Room, or to any equipment, item, material or other facility provided therein ("**Materials**").
6. The availability of the Materials is on a '*first come first served*' basis. No Materials may be booked, reserved or removed from the Room.
7. All Materials shall be used with utmost care, and be returned to its original place immediately after use.
8. The Room and Materials shall be used only for the specific purposes for which they are intended for.
9. All persons must immediately vacate the Room upon instruction of the Management.

SWIMMING POOL

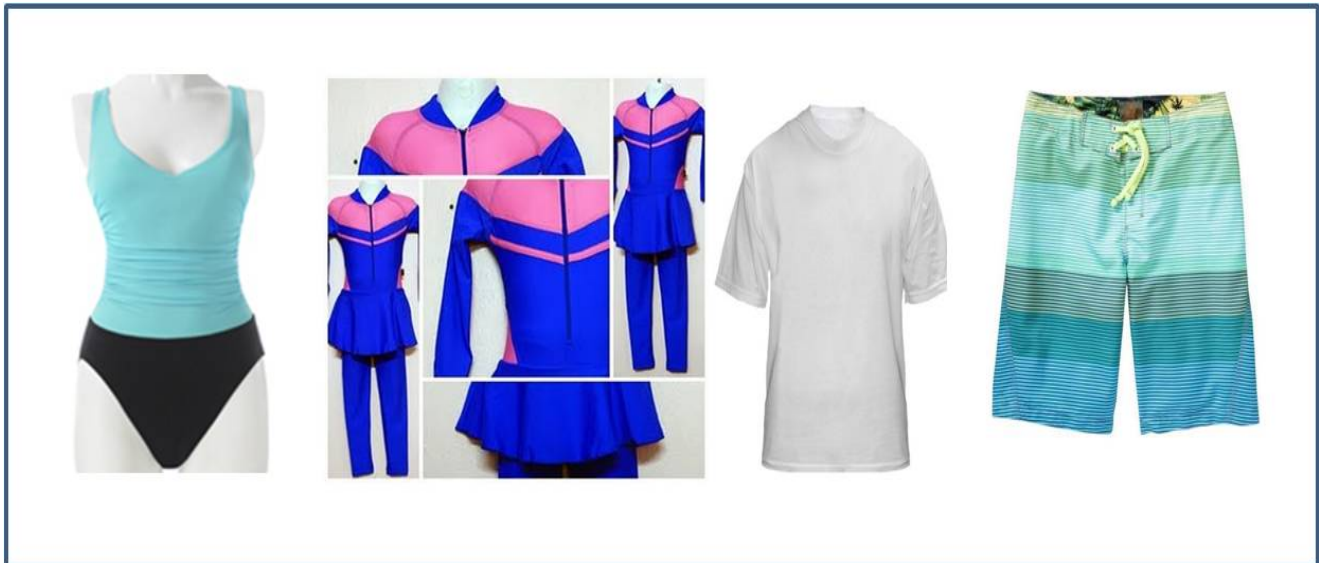
NOTICE:

- (I) **All persons shall enter and use this Swimming Pool ("Pool") at their own risk, and are solely responsible for acquainting themselves with, and are deemed to have full knowledge of all risks involved in and/or related to the Pool and the activities herein.**
- (II) **All persons are aware and have full knowledge that there is no life guard in and around the Pool.**
- (III) **The Management is not liable or responsible for any cost, expense, loss or damage, accidents, personal injury or death howsoever caused to or incurred by any person in or around the Pool.**
- (IV) **The Management is entitled at any time and from time to time at its absolute discretion, to amend, change, delete and/or vary any one or more of the rules below, and/or to impose new rules.**

RULES AND REGULATIONS:

1. Operational Hours are from 7.30 a.m. - 10.30 p.m. daily except when closed by the Management (*whether for maintenance works or otherwise*).
2. All persons intending to use the Pool:
 - 2.1. Must first register at the designated Registration Counter and shower at the designated shower areas before entering the Pool.
 - 2.2. Must be attired in proper swimming/bathing suits - males in swimming trunks, and females in bathing/swim suits. Muslim males may wear tights and Muslim females may wear leotards. All changing into or out of swimming/bathing suits must be done at the designated Changing Room.
 - 2.3. Must remove all shoes, slippers and other footwear before entering the Pool.
 - 2.4. Must not be under the influence of any alcohol, tranquillizer or other drugs, or suffering from any open sore or infection/contagious disease.
3. Children below 12 years intending to use the Pool must be accompanied and supervised at all times by an adult.
4. Pets, smoking, food, drinks, littering, horseplay, dunking, ball sports, water sports, spitting, spouting water, nose blowing or urinating, holding private functions, cycling, skating or any other activity which may cause annoyance, injury or nuisance to other Pool users, are all not permitted in and around the Pool.
5. Save for floats and swim kick-boards, no balls, flippers, boats, inflatable mattresses, scuba gear, surfboards or other objects may be brought into the Pool, and no diving or plunging into the Pool is permitted as the Pool is shallow.

6. No tampering, damage or loss shall be caused to the Pool, its surrounding areas, or to any equipment, item, material or other facility provided therein ("**Materials**").
7. The availability of the Materials is on a '*first come first served*' basis. No Materials may be booked, reserved or removed from the surrounding areas of Pool.
8. All Materials shall be used with utmost care, and be returned to its original place immediately after use.
9. During rain, lightning and/or thunder, no person is permitted in or around the Pool.
10. The Pool and Materials shall be used only for the specific purposes for which they are intended for.
11. All persons must immediately vacate the Pool and its surrounding areas upon instruction of the Management.
12. All persons leaving/vacating the Pool and its surrounding areas must be fully and properly towel dried.
13. The Management is entitled to prevent any person not complying with the above from entering the Pool or its surrounding areas, and/or to expel any person not complying with the above, from the Pool or its surrounding areas.



SAUNA

NOTICE:

- (I) **All persons shall enter and use this Sauna ("Sauna") at their own risk, and are solely responsible for acquainting themselves with, and are deemed to have full knowledge of all risks involved in and/or related to the Sauna (including the possible risks of nausea, dizziness and/or fainting from usage of a sauna), and have deemed to have consulted their physicians/doctors.**
- (II) **The Management is not liable or responsible for any cost, expense, loss or damage, accidents, personal injury or death howsoever caused to or incurred by any person in or around the Sauna.**
- (III) **The Management is entitled at any time and from time to time at its absolute discretion, to amend, change, delete and/or vary any one or more of the rules below, and/or to impose new rules.**

RULES AND REGULATIONS:

1. Operational Hours are from 9:00 a.m. - 9:00 p.m. daily except when closed by the Management (*whether for maintenance works or otherwise*).
2. Children below 16 years are not permitted to enter the Sauna.
3. All persons intending to use the Sauna:
 - 3.1. Must first register at the designated Registration Counter and shower at the designated shower areas before entering the Sauna.
 - 3.2. Must be suitably, properly and decently attired, and must remove all shoes, slippers or other footwear before entering the Sauna.
 - 3.3. Must not be under the influence of any alcohol, tranquillizer or other drugs, or suffering from any open sore or infection/contagious disease.
 - 3.4. Must not place any article (*including towels and clothing*) above, near or on the hot coals, and must not pour any water or other liquid over the heaters.
4. Pets, smoking, food, drinks and littering, are all not permitted in the Sauna.
5. No tampering, damage or loss shall be caused to the Sauna, or any equipment, item, material or facility provided therein ("**Equipment**").
6. The availability of the Equipment is on a '*first come first served*' basis. No Materials may be booked, reserved or removed from the Sauna.
7. All Equipment shall be used with utmost care, and be returned to its original place immediately after use. The Sauna and Equipment shall be used only for the specific purposes for which they are intended for.
9. All persons must immediately vacate the Room upon instruction of the Management.
11. All persons leaving/vacating the Sauna must be fully and properly towel dried.
12. The Management is entitled to prevent any person not complying with the above from entering the Sauna, and/or to expel any person not complying with the above, from the Sauna.

GYMNASIUM ROOM

3. All persons intending to use the Room:
 - 3.1. Must first register at the designated Registration Counter.
 - 3.2. Must be suitably, properly and decently attired (*swimming or other wet attire is not permitted*) and must wear only rubber-soles shoes. All changing into or out of such attire must be done at the designated Changing Room.
4. Pets, smoking, food, littering and personal coaches/instructors are all not permitted in the Room.
5. No tampering, damage or loss shall be caused to the Room, or any equipment, item, material or facility provided therein ("**Equipment**").
6. The availability of the Equipment will be on a '*first come first served*' basis. No equipment may be booked, reserved or removed from the Room.
7. All Equipment shall be used with utmost care, and be returned to its original place immediately after use.
8. The Room and Equipment shall be used only for the specific purposes for which they are intended for.
9. All persons must immediately vacate the Room upon instruction of the Management.
10. All persons leaving/vacating the Room must be fully and properly towel dried.
11. The Management is entitled to prevent any person not complying with the above from entering the Room, and/or to expel any person not complying with the above, from the Room.

TENNIS COURT

NOTICE:

- (I) **All persons shall enter and use this Tennis Court ("Court") at their own risk, and are solely responsible for acquainting themselves with, and are deemed to have full knowledge of all risks involved in and/or related to the Court and the activity herein.**
- (II) **The Management is not liable or responsible for any cost, expense, loss or damage, accidents, personal injury or death howsoever caused to or incurred by any person in or around the Court.**
- (III) **The Management is entitled at any time and from time to time at its absolute discretion, to amend, change, delete and/or vary any one or more of the rules below, and/or to impose new rules.**

RULES AND REGULATIONS:

1. Operational Hours are from 9:00 a.m. - 9:00 p.m. daily except when closed by the Management (*whether for maintenance works or otherwise*).
2. All persons intending to use the Court must first make a prior booking with the designated Registration Counter.
 - 2.1. Booking of the Court shall be made at least 2 clear days in advance, and shall be for a maximum of 1 hour per day only per Licensee. Any extension of time is at the sole discretion of the Management.
 - 2.2. Booking shall be on a '*first come first served*' basis.
 - 2.3. If a person fails to turn up/be present within 10 minutes of the time allotted to him/her, the booking shall be deemed cancelled and the Management is entitled to allot the Court to another Licensee.
3. All persons entering the Court must be suitably, properly and decently attired (*swimming or other wet attire is not permitted*), and must wear only rubber-soles shoes. Persons barefooted or wearing slippers are not permitted into the Court.
4. Pets, smoking, food and littering are all not permitted in the Court.
5. No tampering, damage or loss shall be caused to the Court, or any other equipment, item, material or facility provided therein ("**Equipment**").
6. All Equipment shall be used with utmost care, and be returned to its original place immediately after use.
7. The Court and Equipment shall be used only for the specific purposes for which they are intended for.
8. All persons must immediately vacate the Tennis Court immediately when their session of play ends, or upon instruction of the Management.
9. All persons leaving/vacating the Court must be fully and properly towel dried.
10. The Management is entitled to prevent any person not complying with the above from entering the Court, and/or to expel any person not complying with the above, from the Court.

CHANGING ROOM
